#### CHAPTER BUSINESS

#### RECOMMENDED CHANGES FOR THE ICG

Since the beginning of July, we've witnessed quite a bit of discussion on the ICG-D mailing list, concerning policy and procedure. The ICG has had communication issues since its inception. We've come to realize that the way things are isn't necessarily the way things should stay.

To that end, in this issue and the next, we will be publishing the following preliminary proposals:

- 1: Amending the dues renewal date
- 2. Adoption of a standard ICG Membership Application
- 3: Adoption of the ICG Membership Card
- 4: Creating the position of Membership Coordinator
- 5: Modifying Standing Rule 5 (Membership Processing) to change the responsibilities of the chapter, Corporation Treasurers, and (possibly) Membership Coordinator.

(In Volume II, Issue 1, January/February, 2003) 6: Increasing domestic ICG Membership Rates and setting International ICG Membership Rates to cover *The ICG* Newsletter/ICG Annual

- 7: Setting a Household Membership Rate for the ICG 8: Ceasing publication of Costumer's Quarterly (CQ)
- These proposed changes will be brought before the ICG Annual Meeting next April in Chicago, IL at Costume-Con 21. Your feedback is necessary to help move the process forward. Please read through each item. Some of the

language is stiff - legalese is often like that. We're hoping

Note that these items are NOT the final versions to be presented at the Annual Meeting.

#### 1: Amending the dues renewal date:

to make more as needed.

To be moved: That the ICG officially adopt the single annual membership period of January 1 through December 31 of each year, effective January 1, 2003. Membership applications and renewals postmarked prior to June 30 of each year shall be assessed the full membership fee (noted in Section 3 of the ICG Standing Rules). Membership applications and renewals postmarked July 1 through December 31 of each year shall be assessed one half the full membership fee (noted in Section 3 of the ICG Standing Rules). New and renewing

memberships received prior to January 1, 2003 will be handled using the current expiration date assignment method dictated in the existing version of Standing Rule 5. Renewing members whose ICG memberships exist prior to December 31, 2002 will be assigned the new expiration date (December 31) as their memberships are renewed during 2003. Members who have prepaid for memberships beyond 2003 will automatically be extended through to December 31 of the year in which their memberships expire.

# 2. Adoption of a standard ICG Membership Application:

To be moved: That the ICG and its active chapters adopt the ICG Membership Application Form (as submitted) for processing of all member applications and renewals, effective January 1, 2003. [Note: Form to be finalized before this motion is actually made. Watch this space for a sample version, in the next issue! Current version of the form located here:

### 3: Adoption of the ICG Membership Card

To be moved: That the ICG adopt a form of Membership Card, to be sent with annual renewal notices to every member of the ICG. Card to be based on samples provided by Dora Buck (NJ/NYCG). Card to be used to secure discounts for members. [Samples available on the ICG web site at: www.costume.org/]

# **4:** Creating the position of Membership Coordinator

To be moved: That the ICG establish an appointed position of Membership Coordinator. The Membership Coordinator would be responsible for managing membership processing, notification to chapters, generating Renewal forms, creating and distributing membership cards, etc. The Membership Coordinator would report to the Corporation President and Treasurer. [This position will need to be included in the Standing Rules.]

5: Modifying Standing Rule 5 (Membership Processing (Choose one):



5a: To be moved: That Standing Rule 5 read as follows:

### 5) Membership Processing:

a. New Members shall be required to fill out and submit the ICG Membership Application Form, completed as noted on the form, together with all appropriate dues for the chapters/subscriptions requested thereon, to the **chapter Treasurer**.

b. Each **chapter Treasurer** shall forward the original Membership Application Form, together with monies received from the member within thirty (30) days of receipt to the **Corporation Treasurer**.

c. Annually, on the seventh (7th) day of January or the next business day following, the **chapter Treasurer** will provide the **Corporation Treasurer** with a list of the names and addresses, with phone numbers (where provided) of all members for whom Membership Application Forms and dues have been paid. The **chapter Treasurer** shall remit additional membership update lists as described above at a minimum of one update to the **Corporation Treasurer** on the seventh (7th) day of July or the next business day following; such updates shall include changes of names and addresses, with phone numbers (where provided) of existing members. Such updates shall also include any changes in membership

d. Effective January 1, 2003, all new members whose dues are received by the **Corporation Treasurer** will be assigned a membership expiration date which shall be December 31, the last day of the Corporation's Fiscal Year. Renewing members' expiration dates will automatically be set to December 31, the last day of the Corporation's Fiscal Year. [Adopted 2/15/90; amended 5/25/62, 2/15/93, 5/29/95 and "TBD"]

5b. To be moved: That Standing Rule 5 read as follows:

#### 5) Membership Processing:

b. **The Corporation Treasurer** shall shall forward copies of the Original Membership Application Form, together with monies received from the member within thirty (30) days of receipt to each **chapter Treasurer** for whom dues have been received.

c. Annually, on the seventh (7th) day of January or the next business day following, the **Corporation Treasurer** will provide each **chapter Treasurer** with a list of the names and addresses, with phone numbers (where provided) of all members for whom dues have been paid. The **Corporation Treasurer** shall send at a minimum one update to each **chapter Treasurer** on the seventh (7th) day of July or the next business day following; such updates shall include changes of names

and addresses, with phone numbers (where provided) of existing members. Such updates shall also include any changes in membership status.

d. Effective January 1, 2003, all new members whose dues are received by the **Corporation Treasurer** will be assigned a membership expiration date which shall be December 31, the last day of the Corporation's Fiscal Year. Renewing members' expiration dates will automatically be set to December 31, the last day of the Corporation's Fiscal Year. [Adopted 2/15/90; amended 5/25/62, 2/15/93, 5/29/95 and "TBD"]

The **chapter Treasurer** shall remit additional membership update lists as described above at a minimum of one update to the **Membership Coordinator** on the seventh (7th) day of July or the next business day following; such updates shall include changes of names and addresses, with phone numbers (where provided) of existing members. Such updates shall also include any changes in membership status



#### PROCEDURAL STUFF

**For Your Information:** To process the motions in this and the upcoming issue of The ICG Newsletter, we will likely use a method of discussion called a "committee of the whole." The procedure is used occasionally to allow for free discussion in meetings, to help beat out the details in an easier manner, without the formal meeting structure.

When the committee of the whole has fully considered the matter referred to it, the committee will "report" back to the meeting, for any action to be taken. A mover and seconder are required for each recommendation. Amendments may be proposed in the usual manner. Because the only minutes kept are those of the regular meeting, it is important that any action wanted be correctly reported to the meeting from the committee session and that proposed motions be made regarding the action required.


