ICG Board of Directors (BoD) Meeting

Meeting Opened from Recess

Approve 2017 Meeting Minutes

Moved, Byron Connell (NY/NJ CG); Seconded, Elaine Mami (LACE). 2017 Meeting Minutes approved by unanimous vote of attendees.

Old Business

Guidelines Revision from Last Year

(ICG Guidelines ensuring fair competition: web page: http://costume.org/wp/icg-guidelines-ensuring-fair-competition/).

There has been no movement on this. Meeting attendees discussed it, including. Elaine Mami (LACE): Where are the problems?

Phil Gust (Webmaster): Intention is to make minor revisions to Guidelines to things like types of competition and technical changes. Expect to revise guidelines every five years or so; not big changes but enough to cover changes in competition. No changes have been moving through the Guidelines Committee.

Marianne Pease (President): propose dissolving the old Guidelines Committee to reform guidelines. The following attendee discussion generally approved of of the proposal. Leslie Johnston (GCFCG) is very interested in participating in the Guidelines Committee. Sébastien Bouchard (Fibre Fantasy Artists of Canada) is interested in a French translation of guidelines.

Phil Gust (Webmaster) noted that ICG tri-fold pamphlet (available on ICG web page: http://costume.org/wp/public-relations/) has translations in English, Spanish, German, French, Swedish.

Numbering Problem in By-Laws

Marianne Pease (President): The Standing rules numbering is incorrect. Byron Connell moves that they be fixed. Seconded by Leslie. Unanimously approved by attendees.

New Business:

Inactivity of ICG Committees and Discussion

Marianne Pease (President): There has been no movement/no activity on committees.

They need to be more accountable and have more regular activity. Discussion followed, including:

Byron Connell (NY/NJ CG): some committees exist at pleasure of president and can be disposed of.

Anne Davenport (Recording Secretary): suggest committee people give president reliable communications. Possibly re-appoint people with more reliable contact means.

Jeanine Swick (Treasurer): I don't know who is on the committees.

Multiple attendees agreed with the suggestion to clean house.

Anne Davenport (Recording Secretary): I'm in charge of keeping track of who's on committees and I just look at the web page to find out who is on them.

Discussion among members about the web page and Committees. Committees need active goals. Some standing Committee members are required by By-Laws to be appointed annually. Attendees suggested/discussed putting a form on web page, so people know how to contact committees?

Anne Davenport (Recording Secretary): About contacts via addresses on web page; I've been on BOD for a year and have received no e-mail at recording Secretary e-mail, except for the test message I sent to myself last week to confirm that it works. Meeting attendees agreed that it is a good idea for better contact information.

Inquiry from President about ICG Chapter Status and Discussion

Marianne Pease (President): How are Chapters doing? Verbal reports can be given at meeting; written reports should be sent to Recording Secretary.

Discussion among meeting attendees about getting new conventions to use/try out ICG Guidelines.

Attendee comments: Smaller town have increased hosting costume conventions: Canada, DC, Chicago.

Introduce new/small cons to Guidelines would be work for the PR Committee.

How should ICG breach the generational divide between costumers and cosplayers? Cosplayers do just what we do. There are different flavors of costuming:

- - Costume building
- - Cosplaying: action, enactment

2 halves of the same things.

The previous discussion led to further discussion among meeting attendees about ICG Chapters getting more active in general.

Options considered: Fan table outreach? It is hard to staff convention fan tables. Chapter activity: example is that GCFCG members just do Balticon.

Discussion mentioned that chapter members are not going to all area cons, some avoid some cons that other go to. Newer conventions don't understand the moving F/SF con model (such as CostumeCon and Worldcon) that move to different cities every year. ICG needs persistant contact with local chapter.

Karen Heim (SLCG) SLCG has convention follow up and meetings

Further discussion among attendees included representatives from MACS, Sick Pups, LACE Northern Lights.

Suggest signing up people for meeting list (such as on facebook) can improve member contact so Chapters can be proactive with contacting people. Some chapters are having trouble keeping people. Some chapters have broader, changing geographical boundaries; members are scattered around large area, but send in their dues. Some chapters are centrally located. The same small number of people come to meetings and number of attendees depends on location of meeting. Some chapters sponsor con activities, such as masquerade awards, after parties.

Activities were suggested by the attendees.


Sponsor events in public spaces.

Jacalyn Boggs (NoVA) noted that some places have limited public spaces and are reserved ½ year in advance and are not available. Northern Virginia is bad for having public spaces for meetings.

Sometimes Chapters pair membership with other things, such as JoAnn's discount cards. Another activity is bidding for CostumeCon - - - Annoucement: Baltimore is bidding for CostumeCon 40. More discussion about this, getting a con-runner mentor.

Other Chapter activity: give out hall costume awards.

Marianne Pease (President): ICG needs to adopt a costume duality, to bridge generation gap between costumers and cosplayers.

Summary of the 2018 President's Remarks

My personal theme for the past year has been "Building a Foundation" It's been a learning experience as well as I've gotten used to the position of President, and I'm grateful for the help and guidance Philip Gust has generously provided as well as the long-standing service of officers like Jeanine Swick for keeping us all on the straight and narrow. Philip's leadership left us in an great place financially and with many wonderful programs just begging for people to take advantage of them. This year we have gotten several foundational pieces in place so we can start moving forward again and building up the International Costumers' Guild as an organization that people want to join and support.

We have opened new avenues of communication for our global membership with Slack and the Facebook group. We also now have our beautiful new website up and running, after an enormous effort on the part of our tech committee. Unfortunately, the ICG Archives has been offline for quite some time as the software supporting it is no longer secure or supported by modern web software. Having it down is a blow but we have a team volunteering their time and talent to transfer the enormously valuable collection to a modern software that can support it properly. This will unfortunately take some time but when it's done, it'll be back and better than ever! All told, I'm pleased with the platform that we've established and believe that it's something we can build off of in several directions.

I'm especially pleased that we have a large new chapter in New Orleans forming up right now, and the Cosplay Photography SIG that's taking advantage of our programs. Both groups have come to us as already operational organizations and I think we could do really well recruiting other small cosplay organizations and bringing them into our community. We have a lot to offer organizations as a whole, more than we really offer to individual costumers, and I think should try to reach out to similar cosplay clubs around the country to offer our support as well as work to develop products that these small clubs as well as our current chapters would find valuable.

The other issue that I've been investigating during my first term as president is a problem that all organizations face- where only a small fraction of members are interested in stepping up to do the hard work that goes into running our chapters and the ICG as a whole. Time and again as I've talked to members around the country I've run into this issue. While many members are very interested in attending fun and educational guild events, fewer are willing to step up and do the work to hold them. Symptoms include struggling to fill guild officer positions, a lack of events being organized on a chapter level, and even disinterest in attending events that are planned. Even some of our chapters that are outwardly doing very well with actively planned and executed events are doing so well only because a few individuals are doing all of the work. It's a problem we've discussed on the BoD list and that I've discussed individually with several of you too, and while there isn't a single easy solution. However, it is something that we can combat because the keys are all in place for us to use.

I assume, since everyone here is here and attending the member meeting that you are some of the most involved and active members of your chapters. Many of us will be either on stage or helping run one of the shows this weekend and we are the people who can really make a difference in the community. I would like us all to increase our engagement and consider how we are representing the ICG to the rest of the costuming community. Fight back against the "-isms" Sexism, Racism, Ageism- we don't want to be a group that excludes people and sometimes we need to be more actively welcoming of everyone instead of passively welcoming.

Local community engagement. Some of our chapters, like the Portland Time Travelers' Guild, do this really well. They've built relationships with other groups in the costuming and convention communities. When other organizations hold events, the Time Travelers' will show up and support it- and vice versa!

Transparency. I think that the ICG is run in a very opaque fashion. It's not something that we are trying to do but it has happened anyways. Until I decided to run for President I didn't really feel any connection to the wider ICG community even though I wanted to. I would like to encourage members become more involved on the ICG level. I would love to see more members joining our committees. Chapters vary in size and obviously aren't going to send a member to participate in every committee but I hope that the Treasurers will join the Budget Committee and participate in the discussions there- as is encouraged in our Standing Rules! I know the Publications and PR committees would also welcome representatives from each chapter to help with their work too. The more people who participate in these committees, the more they can accomplish. I have a laundry list of things I'd like the Tech Committee to do, and we are restricted by the time our members can volunteer. By serving on these committees, and gaining experience with process of how they and the ICG as a whole function.

I look forward to growing the ICG through the next few years and hope that we can bring a greater degree of participation on all levels of the organization.

ICG Website

The new ICG website officially went live on Marcy 12, 2018 after over six months of refinement, testing and feedback. the ICG web team for all their hard work over the last two years to make this a reality, including Jacalyn Boggs, Andrew Assarattanakul, and Susan Toker.

Jacalyn did the bulk of the work to move the main website content over, and received a 2017 President's award for her work. Andrew moved over the years of ICG news items and the entire International Costumer newsletter archive. I also want to recognize Kathe Gust, who spent many days laboriously proofreading every page of the new website and correcting a number of problems that came over from the old website. Finally, special thanks to ICG President Marianne Pease for her continued encouragement and support.

The web team is tremendously proud of the results, and we hope that ICG members will be too. Most importantly, this new web platform will enable us to offer many new kinds of content in the future as well as exclusive members-only content. ICG President Marianne Pease will discuss her vision for these in a future article.

ICG Gallery

The International Costumers Gallery is temporarily offline as we turn to the task of moving it over to the new platform. We will do our best to bring it back online as soon as possible, with many new features and viewing options for both desktop and mobile browsing.

We were unable to continue running the current Gallery2 based gallery because we needed to switch to the latest version of the web software (PHP 7) to support Wordpress for the new website. Gallery2 is orphaned software that has not be updated by its developers for the past three years, and does not support this new version of the web software without some significant development work on our part.

There is no software product that meets all of the Archive's requirements. We have identified at least one possible replacement gallery system (Piwigo) and have prototyped it, however, some additional development will be required to enhance some the features to match those of Gallery2 that the Archives relies on. We will continue evaluation and making the enhancements over the summer, with the goal of bringing the International Costumers Gallery back up in the Fall of 2018.

Yahoo Groups

Promise, the company that purchased assets from Yahoo including Yahoo Groups, has recently stated that it is "de-emphasizing" Yahoo Groups. There has been no announcement about its

ultimate fate, but they are not putting many resources into its maintenance. Several years ago, the web team began archiving the ICG-BOD group Conversations area and that is ongoing. These are corporate records of our board meetings. We recently began archiving the Polls area, whose results are also reported in the conversations. The archived ICG-BOD conversations and polls are archived in a way that we can put them online quickly and move them to a different platform.

We were in the process of setting up archiving of the Documents area when we discovered that It has become unavailable. This has become a sporadic problem for other Yahoo groups users, and in many cases the problem resolves itself after a while. We have reported this to Yahoo support, but have no indication of when our Documents area will become available. Fortunately, these are working documents and our permanent records are safely stored on our website. We will find a different way to share working documents until the problem is fixed.

We hope to experiment with reposting our archived conversations on Slack and other alternatives to see if that would be practical.

We began the year 2017 with 479 members in 21 chapters and 3 SIGs. At the end of the year our membership comprised 392 members in 20 chapters and 3 SIGs. We have one chapter in the process in the process of reorganizing and getting their memberships back up to date.

Marty Gear Memorial Costuming Arts and Sciences Fund: No grant applications were received in 2017.

The year began with \$26,351.68 in assets in our combined checking and savings accounts held at the Digital Federal Credit Union.

And we ended with a total of \$28,392.92 in assets in our combined checking and savings accounts held at the Digital Federal Credit Union.

Current account balances as of Mar 31, 2018: General Funds \$22,558.65, Archive Funds \$4,711.31, Grant Funds \$1,911.21 for a total of \$29,103.08.

Income for the year was \$3,465.38 from dues and direct donations to the ICG. Expenses for the year were \$1,384.15 going to archive acquisitions, website, newsletter expenses and operating expenses. Our net income for the year 2017 was \$2,081.23. Copies of the reports are available on the ICG website.

2018 ICG Archives Report

This year's Archives activities have been a series of ups and downs – mostly ups of one sort or another.

Last summer, we finally got around to digitizing the Angelique Trouvere photo collection. This was done as part of our free digitizing service to people with photo print collections. We've set a goal this year to finally scan and inventory the rest of Pettinger collection. We'd like to finally return it to them!

We are currently negotiating to acquire and digitize the Jack Krolak photo print collection, and download his digital photos. This will possibly be the largest addition to the Archives to date, as it includes tens of thousands of images. We are also in contact with another photographer who had just started to upload his collection to the Gallery, until.....

As of sometime last September 2017, the Gallery went offline and has been ever since. The short explanation is the server that the Gallery was on was "upgraded" and that upgrade is not compatible with the very old Gallery software. Philip Gust has been trying to get it back online, but Life and Job have a way of interfering. There is no estimated time of resolution as of yet, although it is hoped it will happen this year: it has been said that the Gallery has been one of the best promotional tools the ICG had. Once it is finally back online, there is a plan to migrate the data to a new photo gallery platform. This is still under investigation.

On a parallel track: Most people are probably not aware that Nora Mai has been helping to maintain the Costume-Con Gallery. In the last 4-5 years, there have been some problems getting the data. Some masquerade directors did not think to save the information for the ICG Archives or for the CC Archives. We still do not have certain participants or winners lists for some masquerades and fashion shows. We've been promised those lists in the past, but most have not materialized. As a result, Nora has had to resort to listening to the videos and guess at how people's names are spelled. We want to plead to any and all future CC chairs and MDs who may be at this meeting to help us collect the data on site, AT THE TIME, to have a complete record of our history.

While the Gallery may be down, we still have the ICG Gallery Facebook page. We now have over 800 followers, and it has been a very effective promotional tool. It is there we've been able to share photos that have not been seen yet, announce the loss of artists from our community, announce new acquisitions and add data to the Archives that we didn't have by asking our followers for their help.

Speaking of acquisitions, we recently purchased some rare photos of Forrest J Ackerman's costume and a photo of participants in the 1956 Worldcon masquerade. Video acquisitions have

slowed down of late (mainly because of Life), but we did recently transfer some digital videotape recordings from the St. Louis area, including the unreleased "official" video from the 2007 NASFIC masquerade.

While there hasn't been any new videos added to the Archives YouTube channel in the past year, we did produce some video material for ICG member Carole Parker, who presented them at panels for Worldcon in Helsinki, last year. She says the panels were very well attended. We have been asked to produce more material for this year's Worldcon. (With enough lead time, the Archives is open to creating video materials for the chapters by request.)

Since Archon is the "home convention" for the St. Louis-based Archives, it gets the benefit of having the Archives Road Show every year as part of their programming, along with any new panels we present. (The Archivists can bring the Road Show to other conventions, dependent on time, availability and whether they can afford to travel.)

There will be video presentations for both CC masquerade halftimes this year, including a memorial for the costumers lost since CC35, as well as the Road Show panel by the Pettingers.

Finally, we are working on an extensive history of convention costuming, which will include winners lists from (almost) every masquerade since 1939 (with links to photos, where possible), notable events and significant technology and materials that have impacted the hobby. This history is to be uploaded to the new Costume.org website, but we are awaiting help with that, as we know nothing about the Wordpress platform and how to update it. Meanwhile, we have started publishing it on the IC Gallery Facebook page.
